AFEES:

A living legacy

In the beginning, which was during WWII, thousands of pilots and aircrew members were reported to be Missing In Action. More than half of those MIA from the 8th Air Force, for example, were finally reported KIA. Most of those who survived became Prisoners of War for the duration.

A small percentage of those who survived in enemy territory evaded capture or escaped from capture and eventually returned to their units. When they returned they were debriefed and sworn to keep *SECRET* the details of their experiences and the identification of those who helped them evade.

No notification was ever sent to these men and women, lifting the pledge to secrecy they had signed. These individuals were so dependable that some carried that pledge to their grave. Many persons who resisted the enemy by helping downed flyers were caught and executed or sent to prison where survival was most difficult.

A number of American airmen also lost their lives in trying to evade capture, or escape from capture, but that was all in the line of duty. They were under military orders to attempt escape if downed behind enemy lines.

When an individual has walked that fine line between life and death, with a helper or a fellow flyer, they develop a bond that is never severed in their mind! It is that bond which brought the AFEES society into existence and perpetuates it today through those evaders and helpers who still live, the spouses, offspring and new friends dedicated to keeping the spirit alive and well.

It takes action to launch an organization, and it takes others joining in to keep the momentum going. AFEES got its start from the actions of two people, Leslie Atkinson of France, now deceased, working from that side of the Atlantic and Ralph K. Patton, chairman of the AFEES board, from this side.

They found a common interest through Operation Bonaparte, a French operation that helped Ralph and many others to eventually leave the Brest area of France via small boats that took them to Royal Navy gunboats and back to England. The men from Operation Bonaparte became the nucleus for the formation of AFEES in 1964. (See more about the beginning of AFEES on Page 39.)

Records show that Bill Spinning played a major role in the publicity of, and about, those who got together with helpers from France, Belgium and Holland. Patton was assisted by Robert Laux in the search for additional evaders in the U.S. as the helpers were coming together in France, Belgium and Holland. Those who worked together were many. Space does not make it practical to list all the names. You know who you are; if you're here to read this, thanks for what you did!

By 1984 AFEES was well established and ready for expansion. That's when Scotty David volunteered to help expanding the membership. Her success resulted in the society's first annual reunion at Atlanta, Ga., in 1986. An auction to raise funds to assist in hosting helpers was part of the reunion. The auction was patterned after

those held by the RCAF group in Canada and Ross Wiens from Canada helped make it a success.

For years the auction was a part of each reunion. Then, the idea of a raffle was proposed and adopted, so people who could not attend reunions could contribute to the helpers' fund.

Francis and Dorothy Lashinsky have handled that task and been very successful for AFEES. For members and friends who pay annual dues, the raffle is not a substitute for dues.

Work on expanding the membership list went beyond the list of men from the 8th and 9th Air Force who were debriefed in London and Paris. It resulted in finding evaders from other areas where they were debriefed at individual units and not on a theater basis. This current roster shows 288 members from the 8th AF, from the 9th, 29; the 15th, 93; the 12th, 9; the 14th, 5. The 5th, the 10th, the 13th, the RAF and the RAAF have one each.

There are also four from the war in Korea and nine from the war in Vietnam.

As time passes, changes take place. When Heyward Spinks, serving as secretary and treasurer, died, those duties were divided. Paul Kenney served as treasurer until his death when he was succeeded by Francene Weyland, and Clayton David is membership chairman, receiving, recording and forwarding money from dues and contributions to the treasurer.

A newsletter is important to keep members informed. Harry Dolph took on that responsibility and did it well until his death. That's when Larry Grauerholz, an ex-newspaperman, took over and continues to publish quarterly, one of the best newsletters you may receive.

About the same time Harry took over the newsletter, another blessing came into the life of AFEES. Gil Millar, a professional computer programmer, took the information available about individual evaders and helpers, and entered it into a database. Both Harry and Gil were living in Houston, Tex., and worked together. Gil even used a lap top computer to keep helping AFEES as long as he could.

His computer-generated material was shared with several. Ralph and Frank continue to keep the info updated to the best of their ability.

In addition to several members who have written books about their experiences, there have been other major events in the life of the society. They include the special and changing display at the 8th Air Force Museum in Savannah, Ralph's personal contribution of material to the Air Force Academy at Colorado Springs and the production of the *Evade!* DVD and video. Several members and friends have assisted in arranging an exhibit at the old Chanute Air Force Base.

The first 20 large newspaper-size scrapbooks created by Scotty David about the events of AFEES, its members and helpers, were scanned by the Department of Defense onto a computer hard drive for their research in MIA recovery work. That material is now preserved, but is not for sale.

Much of the work that goes into planning and organizing AFEES reunions is performed by Yvonne Daley, whose mother, Anne Brusselmans, drafted her as a messenger in Belgium when she was 10 years old. Yvonne has recruited a great team of loyal friends who assist in making the reunions so enjoyable.

To be certain that AFEES continues to be known by flags and banners, thanks goes to President Richard Smith's family.

For a group of pilots and aircrew who have had trouble getting any official recognition from the U.S. Congress, AFEES continues to achieve much, just as the members did when they served their country and evaded. CARRY ON!

History of AFEES goes back to '64

Before 1961, a Frenchman by name of Leslie Atkinson, a reserve captain in the French Air Force, a member of the executive committee of the Army Resistance Organizations and a Helper for Allied airmen, was inspired by the brilliant work accomplished by the British Royal Air Force Escaping Society. It became his mission to create an association which would bring together American aviators who had escaped from enemy-occupied territory and their European Helpers.

Mr. Atkinson's efforts resulted in the *Air Force Rescue Association* being organized in France.

By July 1, 1963, the project had been approved by the U.S. Embassy in Paris, the U.S. Air Force in Europe, and the President of the French Republic. Leslie's determination to fulfill his objective kept him going. He advertised in Europe and found many Helpers; he advertised in the States and received a few replies.

In early 1961, Ralph Patton went back to France and traced his escape route to Guingamp. There he met Mathurin Branchous, the provincial Resistance leader who had a list of names and last-known addresses of Americans who had escaped by way of *Operation Bonaparte*. When he returned home, Ralph contacted two other men on the list: John T. Emery and Fred T. Schmitt. The three men proceeded with plans for a reunion in Buffalo, N.Y., on May 15-16, 1964, to honor their war-time benefactors.

Letters went out and encouraging responses were received from evaders. Counting family members, 56 persons attended the Buffalo reunion, including 32 evaders, 7 Helpers and 1 evader from Canada. That list was the origin of the U.S. Air Forces Escape & Evasion Society roll.

In the January 1964 issue of the VFW magazine, Leslie's notice appeared on the same page as one from Ralph K. Patton, seeking contacts from "those who escaped from Plouha on the Northern coast of Brittany." Contact was established between Ralph and Leslie and they began to communicate about their common interests.

Leslie Atkinson extended his contacts in Europe beyond France. He corresponded with officials in Belgium, Holland, Norway, Italy and other nations. Belgium, thanks to *Comete*, sent a delegation of 61 to the U.S. in 1974 for celebrations in Detroit, Washington and New York City.

Ralph Patton also developed ties with the Royal Escaping Society of Canada which resulted in a joint reunion in Toronto in 1995, a memorable event for all involved.

The AFEES list contained 33 names at the 8th Air Force Historical Society meeting in Phoenix in 1979 and 50 a year later when the 8th met in Orlando.

In 1982, 28 Helpers attended the meeting of the 8th AFHS in Cincinnati.

That was when Scotty David went to work to locate evaders in the U.S. Armed with a list of 3,000 names, she began her search. By 1986, AFEES had about 400 members and held the society's first annual meeting in Atlanta with 170 in attendance. By dint of personal perservance and hundreds of letters and telephone calls, Scotty continues to locate new members.

Membership reached 949 in 1994, including some 175 men from the 15th Air Force and others units not on the original list. Some 60+ years after World War II, members continue to be found and are listed in the AFEES quarterly journal. The current list of known Helpers world-wide now exceeds 600.
