Men liberated by the Allied ground forces, Swiss internees, those who went down in the Balkans, or who became POW after evading for some period of time do not normally have an E&E number. The Air Force and group they were flying with when they became Missing-In-Action is shown.

"L" after a name denotes a Life Member. \*W\* before an address denotes a winter address and \*S\* the corresponding summer address. Sometimes, however, we don't have a winter address.

The last five pages of the directory includes the known list of widows, friends and Helpers living in the United States. "W" after a lady's name indicates the widow of a former member whose information is also shown.
