### WWII: Saving the world

#### The generation now passing deserves our respect.

They're not getting any younger, and there are fewer every day — America's World War II generation.

They may seem like any other group of old people, mostly retirees now, just old men and women on porches, in nursing homes, parents and grandparents — but they're not.

When they were young, they saved the world.

Remarkable how completely ordinary it seems.

No other generation in world history can make that claim.

Not the Founders of the American Revolution, the ancient Greeks and Romans, nor the baby boomers — not even the early Christians.

Other generations had great struggles; other times had great challenges; but at best here and there were saviors of a town or a country, vanguards of unfulfilled promises, dreamers of visions.

America's World War II generation did not, as a group, achieve the heroism of an individual like Joan of Arc, nor is there any evidence that their "souls were touched by fire," as Oliver Wendell Holmes Jr. described the experience of the Civil War when he had grown old.

But isn't it fitting that victory in the most intense, deadly and important struggle in human history should seem sort of ordinary to those who won it, and those who benefited?

America's World War II generation saved the world because it had to be done, and no one else was available to do it.

It isn't that America's Vietnam generation, for example, both the pro and the con, couldn't or wouldn't have saved the world.

They didn't get the chance.

It isn't that Russians, who actually broke the *Wehrmacht*, or Chinese, who held Japan's best troops in a death grip, or British or French or any of the rest of the world's peoples, didn't win the war.

But they didn't save the world from an unspeakable global evil.

That was the Americans — when, as Winston Churchill said, the "new world came to the rescue of the old."

But they weren't vast forces of history, or legendary warriors. They weren't even all combat soldiers, or Rosie the Riveters.

They were ordinary people — my Uncle Ed, and your mom and dad — who lived in an extraordinary time.

So they did what had to be done.

There was a fair amount of ballyhoo last December at the 50th anniversary of Pearl Harbor, although it got sticky with tensions in the current U.S.-Japan relationship.

In a few years, there will be lots of half-century anniversaries of V-E and V-J Day, maybe some prayerful ceremonies honoring liberation of the death camps.

The ex-Soviet republics might pause to remember that there was once a place called Stalingrad, and it was very important.

There will be fewer alive then who actually did those things, though.

So what that 50 years ago today, or last week, or next year, a lot of people killed and died for famous victories?

This isn't about anniversaries, or the all-World War II newsreel channel that every cable TV system seems to have. It's about the old guy you see on the street, with a little poppy in his lapel, or the blue-haired woman who forgets things and who rides the bus.

Let's take a long, last look at these people now, while we still have a chance.

No one has ever done anything like their achievement before — and God willing, no one will ever have to do anything like it again.

## GIL MILLAR AILING

Our Computer genius and Historian, Gil Millar, is ailing from the effects of emphysema. He is at home under the watchful eye of Frances, his wife and life-long friend. Gil is his same old self with a cheery word and advice to those who want it or will listen to it.

Gil started programming AFEES records many years ago with a list of men provided by Leslie Atkinson. Since then that list has grown to approximately 3,500 names, most of them legitimate but somehow paratroopers got mixed in and most of them have been culled out now, just leaving U.S. Army Air Force members who were shot down and did indeed evade or escape capture from the enemy.

Over the years he updated the files, corrected addresses, entered into the program new evaders and AFEES, and kept the files in perfect order.

When he became ill some six years ago or so, your editor, a stupid hacker as far as computers are concerned, joined forces with Gil and we slowly transferred all his records. We placed them in my computer's hard drive and on back-up disks. There are some 10,000,000 million bytes of information pertaining to AFEES or EVADERS plus several million more bytes making up the programs, definitions, menus, etc. This was a tremendous effort on Gil's part when you consider he practically had to learn the French language to translate some of Leslie Atkinson's records. He lives, sleeps and breathes our AFEES program. This organization owes a great debt of gratitude to Gil.

When you consider he had to teach a hacker like me the basics of Word Perfect, short-cuts running the computer itself, and making certain the information was stored properly with access to the information, he did a heck of a job. I thank him for it and I am grateful to him for his tutoring.

### "TOO OLD, TOO SOFT FOR THE PEACE CORPS?"

The most popular conception of the peace Corps -- That it was President Kennedy's idea, and that it attracts only idealistic college kids who perform essential work -- grossly romanticizes and organization that, charged with ambiguous objectives, struggles to live up to its hallowed reputations. I learned from personal experience that many volunteers are not of that ilk at all...and work and live quite comfortably. Many volunteers neither toughed it out in bug-ridden huts nor toiled in some back-breaking work! They enjoyed fairly comfortable homes and performed jobs ranging from teaching school to cataloging plant species to engineering. They have not been youthful either. In recent years the percentage of "Seniors", those fifty and over has steadily climbed. the recent group of Peace Corps that were being sent to Eastern Europe made up an average of forty-one years! It's not the Peace Corps of "Yesteryears". Married couples are welcome and needed in big cities for environmental, small business and urban development.

How do I join? Do I want to?...I'd like to find out anyway! The first step is to write to the Peace Corps office. You will receive and application and some simple Medical and Dental examinations (paid by the Peace Corps). When you are finally accepted, you have six months in which to get ready. If you have had any connections with the Intelligence Services you will be AUTOMATICALLY disqualified! You cannot choose the country where you want to go..instead you will be given ten days to decide if you want to go or not. If you "YES" everything you'll get a date where you'll meet those going with you and a ticket to a city. In approximately three days you take off for the country chosen! You're traveling with the Peace Corps and are given a Life Insurance policy. You will be paid a living allowance (not too much, not too little, but just enough). You will attend a Peace Corps school for language, cultures and assimilation. I went through it all. I thought I was

joining a vast young Army, even if it's true that I'm slightly grey-haired. Things are pretty good in the Peace Corps and administrators make sure it stays that way. It has it's tiny minute and smattering touch of the U.S. Army, only sweeter, calmer, charming, loving and tender and you can quit at anytime...anytime at all...no excuse required. Of those in the Peace Corps, thirty percent do not finish the entire two years of duty.

I served in Kenya which is rather modern compared to other African countries. Yes, I saw lions, elephants and monkeys but only on my off duty time. We were allowed twenty-four days a year for vacation. Mainly I worked with "Women's groups". The groups are a Kenyan Institution. The women are all friends and they are registered , have a set of "By-Laws", are given a number and choose a name. There is nothing to hold them back..though destitute, they are desperate and miserably poor (legally landless), women. However they lead a peasant life and we all know it's a life committed completely to survival! The town attracted a large number of families daily. Men are searching for a monetized subsistence (average income is \$300 per year). Many of them are Maasai, a tribe once known for its glorious past. But not any more! The different tribes are colorful and dramatic in their "National" native clothing..but drab in their everyday "wrong vestments".

I've learned much of the history of the "Peace Corps" and what better "Jobs" are available for members of the Escape and Evasion Society! The Peace Corps is not a bad deal if you ever want to see a reticulated giraffe or want to tell a Reedbuck from a Steenbuck..come along. However the first thing you should want to be is a volunteer in the Peace Corps. To present, take upon oneself, be gratuitous and become the master of cordiality! The Peace Corps is seeking skilled volunteers for overseas tours. While no upper age limit is imposed, candidates must meet recruitment, placement and Medical requirements.
